## SENATE ORDER FOR ENTITY CONTRACTS LISTING RELATING TO THE PERIOD 1 JANUARY 2024 – 31 DECEMBER 2024

Pursuant to the Senate Order for entity contracts ("Murray Motion"), the following table sets out contracts entered into by the Clean Energy Finance Corporation which meet the following criteria:

- a. valued at or above \$100,000 (GST inclusive); and
- b. entered into prior to 1 Jan 2024 and not fully performed as at 31 December 2024; and/or
- c. entered into during the 2024 annual year.

Most of the contracts contain confidentiality provisions of a general nature that are designed to protect the confidential information of the parties that may be obtained or generated in carrying out the contract.

The reasons for including such clauses include:

- a. ordinary commercial prudence that requires protection of commercial-sensitive contracts, information, trade secrets, proprietary information and the like; and/or
- b. protection of other material and personal information.
